### B. Requirement/s if awarded the contract:

1. Delivery Period: Within Sixty (60) Calendar days after receipt of Notice to Proceed (NTP).
2. Delivery Place: Equipment Section, Property & Supply Division, Philippine General Hospital, Taft Avenue, Manila
3. Warranty Period / Coverage of Warranty: One (1) year warranty on Craftsmanship. Warranty Period shall commence from the date of acceptance by the end user after supply and delivery. the supplier guarantees that reusable instruments can be used the number of times it is stated above. In the event that an instrument malfunctions before its intended usable life, the supplier agrees to give the Philippine General Hospital, Credit Notes of the unused life of the instrument after the evaluation from the manufacturer that the cause of malfunction is product defect. The Credit Notes can be used to procure any instrument or consumable and shall not expire.
4. Signed Service level agreement with the Philippine General Hospital.
5. Original hard copy (not photocopy) or soft copy of operators and service manuals in English Language
6. Acceptance Procedures and Parameters: Visual and Functional Testing.
