Glossary of Acronyms, Terms, and Abbreviations

ABC – Approved Budget for the Contract.

BAC–Bids and Awards Committee.

Bid – A signed offer or proposal to undertake a contract submitted by a bidder in response to and in consonance with the requirements of the bidding documents. Also referred to as *Proposal* and *Tender*. (2016 revised IRR, Section 5[c])

Bidder – Refers to a contractor, manufacturer, supplier, distributor and/or consultant who submits a bid in response to the requirements of the Bidding Documents. (2016 revised IRR, Section 5[d])

Bidding Documents – The documents issued by the Procuring Entity as the bases for bids, furnishing all information necessary for a prospective bidder to prepare a bid for the Goods, Infrastructure Projects, and/or Consulting Services required by the Procuring Entity. (2016 revised IRR, Section 5[e])

BIR - Bureau of Internal Revenue.

BSP – Bangko Sentral ng Pilipinas.

Consulting Services – Refer to services for Infrastructure Projects and other types of projects or activities of the GOP requiring adequate external technical and professional expertise that are beyond the capability and/or capacity of the GOP to undertake such as, but not limited to: (i) advisory and review services; (ii) pre-investment or feasibility studies; (iii) design; (iv) construction supervision; (v) management and related services; and (vi) other technical services or special studies. (2016 revised IRR, Section 5[i])

CDA - Cooperative Development Authority.

Contract – Refers to the agreement entered into between the Procuring Entity and the Supplier or Manufacturer or Distributor or Service Provider for procurement of Goods and Services; Contractor for Procurement of Infrastructure Projects; or Consultant or Consulting Firm for Procurement of Consulting Services; as the case may be, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

CIF – Cost Insurance and Freight.

CIP – Carriage and Insurance Paid.

CPI – Consumer Price Index.

DDP – Refers to the quoted price of the Goods, which means "delivered duty paid."

DTI – Department of Trade and Industry.

EXW – Ex works.

FCA – "Free Carrier" shipping point.

FOB – "Free on Board" shipping point.

Foreign-funded Procurement or Foreign-Assisted Project— Refers to procurement whose funding source is from a foreign government, foreign or international financing institution as specified in the Treaty or International or Executive Agreement. (2016 revised IRR, Section 5[b]).

Framework Agreement – Refers to a written agreement between a procuring entity and a supplier or service provider that identifies the terms and conditions, under which specific purchases, otherwise known as "Call-Offs," are made for the duration of the agreement. It is in the nature of an option contract between the procuring entity and the bidder(s) granting the procuring entity the option to either place an order for any of the goods or services identified in the Framework Agreement List or not buy at all, within a minimum period of one (1) year to a maximum period of three (3) years. (GPPB Resolution No. 27-2019)

GFI – Government Financial Institution.

GOCC – Government-owned and/or –controlled corporation.

Goods – Refer to all items, supplies, materials and general support services, except Consulting Services and Infrastructure Projects, which may be needed in the transaction of public businesses or in the pursuit of any government undertaking, project or activity, whether in the nature of equipment, furniture, stationery, materials for construction, or personal property of any kind, including non-personal or contractual services such as the repair and maintenance of equipment and furniture, as well as trucking, hauling, janitorial, security, and related or analogous services, as well as procurement of materials and supplies provided by the Procuring Entity for such services. The term "related" or "analogous services" shall include, but is not limited to, lease or purchase of office space, media advertisements, health maintenance services, and other services essential to the operation of the Procuring Entity. (2016 revised IRR, Section 5[r])

INCOTERMS – International Commercial Terms.

Infrastructure Projects – Include the construction, improvement, rehabilitation, demolition, repair, restoration or maintenance of roads and bridges, railways, airports, seaports, communication facilities, civil works components of information technology projects, irrigation, flood control and drainage, water supply, sanitation, sewerage and solid waste management systems, shore protection, energy/power and electrification facilities, national

buildings, school buildings, hospital buildings, and other related construction projects of the government. Also referred to as *civil works or works*. (2016 revised IRR, Section 5[u])

- 1. The University of the Philippines Manila, through the *UPM Funds* intends to apply the sum of *One Million Eight Hundred Thousand Pesos (Php1,800,000.00)* being the Approved Budget for the Contract for the payments under the contract for the *UP Manila Manning of CCTV Monitoring Station FY 2023*, *University of the Philippines Manila*". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- The *University of the Philippines Manila* now invites bids for the above Procurement Project. Bidders should have completed, within the last five years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in SectionII (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No.9184.
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 5. Prospective Bidders may obtain further information from the BAC2 Secretariat, University of the Philippines Procurement Management Office and inspect the Bidding Documents at the address given below during office days, 8:00 to 4:00 p.m.
- A complete set of Bidding Documents may be acquired by interested Bidders on 25 November 2022 from the given address and website(s) below The Procuring Entity shall allow the bidder to present its proof of payment for thebidding documents fees amounting to *Two Thousand Pesos* (*Php2*, 000.00) in person, by facsimile or electronic means (email).
- 7. The University of the Philippines Manila will hold a Pre-Bid Conference on *01 December 2022 at 1:30p.m.* through zoom which shall be open to prospective bidders.
 - The BAC conduct meetings via zoom until such time that the implementations of community quarantine or similar government restrictions are lifted by the proper government authorities.
 - **NOTE:** The prospective bidders are advised to register first @ Zoom Meeting Registration Link and wait for further advice for the zoom link which shall be provided to the prospective bidders who successfully registered.
- 8 Bids must be duly received through manual submission, on or before 13 December 2022 not later than

1:00p.m. at Procurement Management Office, 2nd Floor Joaquin Gonzales Compound, Padre Faura St., Ermita Manila. Latebids shall not be accepted.

- All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**Clause 14.
- 10. Bid opening shall be on *13 December 2022*, *1:30p.m*. at the given address below and/or via *zoom*. Bids will be opened in the presence of the bidders' representatives who choose to join the zoom meeting.

NOTE: The prospective bidders are advised to register first @ Zoom Meeting Registration Link and wait for furtheradvice for the zoom link which shall be provided to the bidders who successfully registered.

11. The zoom link will be provided to those who signified their intention to attend. Only those whose names were submitted to the Secretariat will be allowed access to the meeting room. Zoom link should not be shared to otherpeople.

The prospective bidders/suppliers shall stay initially at the zoom waiting room until the discussion of the item where they intend to participate starts. The host of the meeting from the BAC Secretariat will then let them in tothe meeting room just before the discussion of the specific matter they intent to participate.

- The University of the Philippines Manila reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.

Section II. Instructions to Bidders

1. Scope of Bid

The Procuring Entity, *University of the Philippines Manila*, wishes to receive Bids for the "UP Manila Manning of CCTV Monitoring Station FY 2023, University of the Philippines Manila". with Project Identification Number

[Note: The Project Identification Number is assigned by the Procuring Entity based on its own coding scheme and is not the same as the PhilGEPS reference number, which is generated after the posting of the bid opportunity on the PhilGEPS website.]

The Procurement Project (referred to herein as "Project") is composed of [indicate number of lots or items], the details of which are described in Section VII (Technical Specifications).

2. Funding Information

- 21. The GOP through the source of funding as indicated below for 2023 in the amount of *One Million Eight Hundred Thousand Pesos (Php1,800,000.00)*
- **22** The source of funding is: **UPM Funds**

3. Bidding Requirements

The Bidding for the Project shall be governed by all the provisions of RA No. 9184 and its 2016 revised IRR, including its Generic Procurement Manuals and associated policies, rules and regulations as the primary source thereof, while the herein clauses shall serve as the secondary source thereof.

Any amendments made to the IRR and other GPPB issuances shall be applicable only to the ongoing posting, advertisement, or **IB** by the BAC through the issuance of a supplemental or bid bulletin.

The Bidder, by the act of submitting its Bid, shall be deemed to have verified and accepted the general requirements of this Project, including other factors that may affect the cost, duration and execution or implementation of the contract, project, or work and examine all instructions, forms, terms, and project requirements in the Bidding Documents.

4. Corrupt, Fraudulent, Collusive, and Coercive Practices

The Procuring Entity, as well as the Bidders and Suppliers, shall observe the highest standard of ethics during the procurement and execution of the contract. They or through an agent shall not engage in corrupt, fraudulent, collusive, coercive, and obstructive practices defined under Annex "I" of the 2016 revised IRR of RA No. 9184or other integrity violations in competing for the Project.

5. Eligible Bidders

51. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.

- Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to at least fifty percent (50%) of the ABC.
- 5.4. The Bidders shall comply with the eligibility criteria under Section 23.4.1 of the 2016 IRR of RA No. 9184.

6. Origin of Goods

There is no restriction on the origin of goods other than those prohibited by a decision of the UN Security Council taken under Chapter VII of the Charter of the UN, subject to Domestic Preference requirements under **ITB** Clause 18.

7. Subcontracts

Subcontracting is not allowed.

8. Pre-Bid Conference

The Procuring Entity will hold a pre-bid conference for this Project on the specified date and time and either at its physical address {[insert if applicable] and/or through videoconferencing/webcasting} as indicated in paragraph 6 of the **IB**.

9. Clarification and Amendment of Bidding Documents

Prospective bidders may request for clarification on and/or interpretation of any part of the Bidding Documents. Such requests must be in writing and received by the Procuring Entity, either at its given address or through electronic mail indicated in the **IB**, at least ten (10) calendar days before the deadline set for the submission and receipt of Bids.

10. Documents comprising the Bid: Eligibility and Technical Components

- 101. The first envelope shall contain the eligibility and technical documents of the Bid as specified in **Section VIII** (Checklist of Technical and Financial **Documents**).
- The Bidder's SLCC as indicated in **ITB** Clause 5.3 should have been completed within five years prior to the deadline for the submission and receipt of bids.
- If the eligibility requirements or statements, the bids, and all other documents for submission to the BAC are in foreign language other than English, it must be accompanied by a translation in English, which shall be authenticated by the appropriate Philippine foreign service establishment, post, or the equivalent office having jurisdiction over the foreign bidder's affairs in the Philippines. Similar to the required authentication above, for Contracting Parties to the Apostille Convention, only the translated documents shall be authenticated through an apostille pursuant to GPPB Resolution No. 13-2019

dated 23 May 2019. The English translation shall govern, for purposes of interpretation of the bid.

11. Documents comprising the Bid: Financial Component

- 11.1. The second bid envelope shall contain the financial documents for the Bid as specified in **Section VIII** (Checklist of Technical and Financial Documents).
- If the Bidder claims preference as a Domestic Bidder or Domestic Entity, a certification issued by DTI shall be provided by the Bidder in accordance with Section 43.1.3 of the 2016 revised IRR of RA No. 9184.
- Any bid exceeding the ABC indicated in paragraph 1 of the **IB** shall not be accepted.
 - a For a multi-year Framework Agreement, the prices quoted by the Bidder during submission of eligibility documents shall be the ceiling and the price quoted during mini competition must not exceed the initial price offer. The price quoted during call for mini-competition shall be fixed during the Bidder's performance of that Call-off and not subject to variation or escalation on any account. Price schedules required under Clause 12.1 shall be submitted with the bidding documents.

12. Bid and Payment Currencies

12.1 Payment of the contract price shall be made in Philippine pesos.

13. Bid Security

- 14.1. The Bidder shall submit a Bid Securing Declaration¹ or any form of Bid Security in the amount indicated in the **BDS**, which shall be not less than the percentage of the ABC in accordance with the schedule in the **BDS**.
- 142. The Bid and bid security shall be valid until one hundred twenty (120) calendar days after the opening of bids. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non- responsive.

14. Sealing and Marking of Bids

Each Bidder shall submit (3) three Copies of the first and second components of its bid. (1) one Original and (2) two additional copies (Copy 1 and Copy 2)

The Procuring Entity may request additional hard copies and/or electronic copies of the Bid. However, failure of the Bidders to comply with the said request shall not be a ground for disqualification.

In the case of Framework Agreement, the undertaking shall refer to entering into contract with the Procuring Entity and furnishing of the performance security or the performance securing declaration within ten (10) calendar days from receipt of Notice to Execute Framework Agreement.

If the Procuring Entity allows the submission of bids through online submission or any other electronic means, the Bidder shall submit an electronic copy of its Bid, whichmust be digitally signed. An electronic copy that cannot be opened or is corrupted shall be considered non-responsive and, thus, automatically disqualified.

15. Deadline for Submission of Bids

16.1. The Bidders shall submit on the specified date and time and either at its physical address or through online submission as indicated in paragraph 7 of the **IB**.

16. Opening and Preliminary Examination of Bids

17.1. The BAC shall open the Bids in public at the time, on the date, and at the place specified in paragraph 9 of the **IB**. The Bidders' representatives who are present shall sign a register evidencing their attendance. In case videoconferencing, webcasting or other similar technologies will be used, attendance of participants shall likewise be recorded by the BAC Secretariat.

In case the Bids cannot be opened as scheduled due to justifiable reasons, the rescheduling requirements under Section 29 of the 2016 revised IRR of RA No. 9184 shall prevail.

172. The preliminary examination of bids shall be governed by Section 30 of the 2016 revised IRR of RA No. 9184.

17. Domestic Preference

18.1. The Procuring Entity will grant a margin of preference for the purpose of comparison of Bids in accordance with Section 43.1.2 of the 2016 revised IRR of RA No. 9184.

18. Detailed Evaluation and Comparison of Bids

- 191. The Procuring BAC shall immediately conduct a detailed evaluation of all Bids rated "passed," using non-discretionary pass/fail criteria. The BAC shall consider the conditions in the evaluation of Bids under Section 32.2 of the 2016 revised IRR of RA No. 9184.
- 192 The Project shall be awarded as ONE CONTRACT.
- Except for bidders submitting a committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation, all Bids must include the NFCC computation pursuant to Section 23.4.1.4 of the 2016 revised IRR of RA No. 9184, which must be sufficient for the total of the ABCs for all the lots or items participated in by the prospective Bidder. For bidders submitting

the committed Line of Credit, it must be at least equal to ten percent (10%) of the ABCs for all the lots or items participated in by the prospective Bidder.

19. Post-Qualification

20.2. Within a non-extendible period of five (5) calendar days from receipt by the Bidder of the notice from the BAC that it submitted the Lowest Calculated Bid, the Bidder shall submit its latest income and business tax returns filed and paid through the BIR Electronic Filing and Payment System (eFPS) and other appropriate licenses and permits required by law and stated in the **BDS**.

20. Signing of the Contract

21.1. The documents required in Section 37.2 of the 2016 revised IRR of RA No. 9184 shall form part of the Contract. Additional Contract documents are indicated in the **BDS**.

TERMS OF REFERENCE FOR THE MANNING

OF CCTV MONITORING STATION

I. General Qualification for Bidder

- 1. The bidder must possess and submit certificates of Good Track record from five (5) government and/or private agencies that they have contracted with for the last three (3) years with a rating of at least "Very Satisfactory" performance.
- 2. Sworn Statement that the bidder has been in the Business of Security and Manning CCTV Monitoring Station for the last three (3) years.
- 3. The bidder is a legal entity separate and distinct from the existing Private Security Agency that is manning the entirety of UPM and PGH.
- 4. Sworn Affidavit of the bidder that it is not related to the Head of Procuring Entity, members of the BAC, the TWG, and the BAC Secretariat, the Head of the PMO or the enduser unit, and the project consultants, by consanguinity or affinity up to the third civil degree.
- 5. The bidder/contractor may be required to provide additional trained and qualified personnel to operate the CCTV system in the event of any emergency as may be determined by UPM Administration.

II. Standard Operation

- 1. 24/7 provision and operation of CCTV monitoring station with three (3) eight-hour shift personnel and one (1) twelve-hour shift supervisor/reliever to man the CCTV monitors and observe suspicious, criminal or unusual activities detrimental to the Hospital and its constituents, guests, and clients.
- 2. Reporting personnel must be in proper uniform with ID at all times.
- 3. Checking and setting up of the surveillance equipment.
- 4. Immediately inform the UP-PGH Chief of Police of any unusual activities occurring in *real time* through two-way handheld radio transceiver or cellular phone and record the same in the logbook. Official report of these activities shall be submitted to the Deputy Director for Administration through UP-PGH Police Office (Security Services Division) within twenty-four (24) hours from the time the incident was seen on the CCTV monitoring system.
- 5. Shall record, store, or preserve the *day-to-day* data (images and videos) recorded in the CCTV system for the period of one (1) month unless a longer period is required of specific data.
- 6. Shall be responsible for the safety of all needed/stored/preserved, as well as all other data and documents related thereto.

- 7. Ensure the physical safety of all machines/equipment in the "CCTV Monitoring Station" e.g., monitors, computer, data storage equipment/recorder, telecommunications equipment, etc.
- 8. Shall aid in the safekeeping of these equipment by observing and reporting the preventive maintenance schedules to the Office of Engineering and Technical Services (OETS) and the Public Assistance and Auxiliary Services (PAAS) at least two (2) weeks before these are due for preventive maintenance assessment.
- 9. Maintain orderliness and cleanliness in their Office.
- 10. Uphold confidentiality of all information collected and processed in the CCTV and the digital files which may only be processed and released in accordance with the University and Hospital policies as well as the Data Privacy Act and its Implementing Rules and Regulations. Shall submit to the Office of Deputy Director for Administration the signed Confidentiality Agreement prior to the assumption of duty of their employees.
- 11. Provide a back up file/system in a digital optical disc storage format (DVD+Rs), flash drive, or other storage device intended for keeping still photographs and video recording for evidentiary purposes.
- 12. During the start of every shift, the operators must make sure all CCTV machines/equipment are operational.
- 13. Play an active role and cooperate with UP-PGH Police and Philippine National Police during investigation of cases.
- 14. Shall attend court trials if requested or ordered to testify and answer questions about a case captured on surveillance camera.
- 15. Coordinate actively and promptly with appropriate PGH units (OETS, PAAS, etc.) regarding any issues with CCTV machines/equipment.
- 16. Submit a summary monthly written report of their tour-of-duty to the Deputy Director for Administration through the Chief of UP-PGH Police citing suspicious, criminal or unusual activities observed, condition of CCTV hardware/software, and the number of days equipment is nonoperational.
- 17. Every quarter, the manning agency shall rotate/replace at least one (1) or two (2) personnel to avoid familiarity with employees and/or possible culprits.
- 18. Shall be evaluated quarterly by the Administration through UP-PGH Police Office using the foregoing standard operation performance criteria; if the CCTV manning agency garnered an overall rating of "Unsatisfactory" or "Poor" in two (2) consecutive quarters, the Administration has the prerogative to unilaterally rescind, revoke, wholly or partially terminate the contract after written notice to the Contractor seven (7) days before the intended date of such pre-termination.

IV. Compensation of Personnel

The company shall comply with all pertinent laws and regulations on Labor, SSS, and other wage-related benefits/compensations of workers.



GUIDELINES FOR THE CONDUCT OF BIDS AND AWARDS COMMITTEE MEETINGS USING ONLINE PLATFORMS (SUCH AS VIDEO CONFERENCING, ZOOM, ETC)

Background and General Principle

Article III, Section 8 of RA 9184 2016 Implementing Rules and Regulations (IRR) provides that "to promote transparency and efficiency, information and communications technology shall be utilized in the conduct of procurement procedure."

The Government Procurement Policy Board through its Technical Support Office (TSO) continuously strived for the development of various on-line systems such as PhilGEPS which serves as the primary source of information on all government procurement. Procurement of common-used supplies and equipment can now be done at the Virtual Store of the Procurement Service. Recently, the development of online training platform was hastened due to the physical restrictions brought about by the community quarantine due to the COVD-19 pandemic.

Development of the online system for the submission of bids is ongoing. However, also due to the pandemic, the GPPB-TSO encouraged procuring agencies to develop their own system but in accordance with the guidelines issued by GPPB-TSO to ensure security, integrity and confidentiality of bid documents submitted.

The conduct of meetings with prospective bidders including prebid conference and opening of bids may now be conducted in person or face-to-face through videoconferencing, webcasting or similar technology with the interested suppliers, contractors and consultants.

In UP Manila, specifically the Bids and Awards Committee (BAC1, BAC2 and BAC3) meetings shall be conducted "face to face" using the online platforms. The manner of holding BAC meetings should be announced and described in the Invitation to Bid at the onset of the procurement activities. It should clearly define the guidelines or procedures to be observed by the prospective bidders and other interested contractors, suppliers, or consultants, as follows:

a. Using the attached Quick Fact Sheet, prospective bidders shall inform the concerned BAC Secretariat of their interest to participate in the prebid conference and opening of bids by sending the name/s of their authorized representative/s and their corresponding email address/es at least, the day before the meeting, to the following email addresses:

BAC 2 : <u>upm-bac2-secretariat@up.edu.ph</u>
BAC 3 : upm-bac3-secretariat@up.edu.ph

- b. The zoom link which shall be provided by the BAC Secretariat to those who signified their intention to attend at least one (1) hour before the scheduled start of the meeting. Only those whose names were submitted to the Secretariat will be allowed access to the meeting room. Zoom link should not be shared to other people.
- c. The prospective bidders/suppliers shall stay initially at the zoom waiting room until the discussion of the item where they intend to participate starts. The host of the meeting from the BAC Secretariat will then let them in to the meeting room just before the discussion of the specific matter they intend to participate.
- d. During discussion, participants shall be requested to put their audio/microphones in "mute" mode, and shall unmute only upon raising their hands and have been given by the presiding officer the permission to speak.
- e. Participants shall open their camera when speaking for proper recognition.
- f. After discussion, all prospective bidders/suppliers for a particular project will courteously be requested to leave the meeting.
- g. Attendance to the zoom meeting should be documented. Likewise, the proceedings/minutes of the meeting should be recorded.
