## Invitation to Bid

### **SUPPLY OF 3RD AND 4TH TRANCHES OF RICE SUBSIDY FOR FY 2018**

1. The University of the Philippines-Manila, through Revolving Fund-PS, 184-136A, 184-142B, 184-142, Fund 164, Fund 184, Trust Fund intends to apply the sum of **Fourteen Million Seven Hundred Sixty Nine Thousand Pesos (Php 14,769,000.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for Supply of 3<sup>rd</sup> and 4<sup>th</sup> Tranches of Rice Subsidy for FY 2018. **Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. The University of the Philippines-Manila now invites bids for Supply of 3<sup>rd</sup> and 4<sup>th</sup> Tranches of Rice Subsidy for FY 2018. Delivery of the Goods will depend on the bidding results/ schedule of delivery with winning bidders. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting on **October 10, 2018** from the **BAC Secretariat Office at 8<sup>th</sup> Floor Central Block Building, Philippine General Hospital, Taft Avenue Ermita, Manila** and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Fifteen Thousand Pesos (Php 15,000.00)**.
6. Bids must be delivered to the address below on or before **November 05, 2018 11:30 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
