SUPPLY OF AUTODELFIA NEONATAL KIT/SOLUTIONS/REAGENTS

1. The **University of the Philippines-Manila**, through **Fund 184-142** intends to apply the sum of **Thirty-Three Million Three Hundred Eighty-Four Thousand Five Hundred Seventy-Five Pesos & 00/100 (Php 33,384,575.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **Supply of Autodelfia Neonatal Kit/Solutions/Reagents. Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. The University of the Philippines-Manila now invites bids for **Supply of Autodelfia Neonatal Kit/Solutions/Reagents.** Delivery of the Goods is required **Sixty (60) Calendar days from receipt of Contract/Purchase Order.** Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project **amounting to 50% of the ABC of this project to be bid.** The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting on **May 22, 2020** from the **BAC Secretariat Office** at **4th Floor UP Manila Dormitory Pedro Gil Street Taft Avenue, Ermita Manila,** and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Thirty-Three Thousand Four Hundred Pesos & 0/100 (Php 33,400.00).**
