# SUPPLY OF VARIOUS LABORATORY SUPPLIES FOR NEWBORN SCREENING CENTER (REBID)

- 1. The University of the Philippines-Manila, through Fund 2020101000 184-142 intends to apply the sum of Eighteen Million Three Hundred Ninety Four Thousand Nine Hundred Fifty Eight Pesos & 40/100 (Php 18,394,958.40) being the Approved Budget for the Contract (ABC) to payments under the contract Supply of Various Laboratory Supplies for Newborn Screening Center (Rebid). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The University of the Philippines-Manila now invites bids for <u>Supply of Various Laboratory Supplies for Newborn Screening Center (Rebid).</u> Delivery of the Goods is required <u>Six (6) Weeks (Staggered Delivery) from receipt of Purchase Order.</u> Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project amounting to at least 25% of the ABC of this contract to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
  - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders starting on <u>03</u> <u>December 2020</u> from the <u>BAC Secretariat Office</u> at <u>4<sup>th</sup> Floor UP Manila Dormitory, University of the Philippines, Pedro Gil St. Taft Avenue Ermita Manila, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Eighteen Thousand Four Hundred Pesos & 0/100 (Php 18,400.00).</u>
- 6. Pre-Bid Conference will be conducted on 10 December 2020, 01:30PM via zoom. Interested Bidder should send the BAC3 Secretariat the name and email address of authorized representative who should be given access to join.
- 7. Bids must be delivered to the address below on or before **22 December 2020 11:30 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18. Late bids will not be accepted/opened.
