SUPPLY OF NEOBASE NON-DERIVATIZED MSMS KIT SCREENING KIT FOR AMINO ACIDS AND ACYLCARNITINES DISORDERS

- 1. The University of the Philippines-Manila, through Fund 2020101000 184-142 intends to apply the sum of Forty Million One Hundred Thousand Five Hundred Pesos & 00/100 (Php 40,100,500.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply of Neobase Non-Derivatized MSMS Kit Screening Kit for Amino Acids and Acylcarnitines Disorders. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The University of the Philippines-Manila now invites bids for <u>Supply of Neobase Non-Derivatized</u> <u>MSMS Kit Screening Kit for Amino Acids and Acylcarnitines Disorder.</u> Delivery of the Goods is required Six (6) Weeks (Staggered Delivery) from receipt of Contract/Purchase Order. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project amounting to 50% of the ABC of this project to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4. Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders starting on <u>06</u> November 2020 from the <u>BAC Secretariat Office</u> at <u>4th Floor UP Manila Dormitory, University of the Philippines, Pedro Gil St. Taft Avenue Ermita Manila, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Forty Thousand Two Hundred Pesos & 0/100 (Php 49,200.00).</u>
- 6. Pre-Bid Conference will be conducted on 16 November 2020, 01:30PM via zoom. Interested Bidder should send the BAC3 Secretariat the name email address of authorized representative who should be given access to join.
- 7. Bids must be delivered to the address below on or before **01 December 2020 11:30 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
