- The University of the Philippines-Manila, through *Fund 101* intends to apply the sum of <u>FOUR</u> <u>MILLION TWO HUNDRED THOUSAND PESOS ONLY (PhP4,200,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for <u>SUPPLY OF</u> <u>Two (2) units CHOLEDOCOFIBERSCOPE – (SINGLE BID)</u>. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The University of the Philippines-Manila now invites bidders for the <u>SUPPLY OF Two (2) units</u> <u>CHOLEDOCOFIBERSCOPE - (SINGLE BID)</u>. Delivery of the Goods is required <u>within sixty</u> (60) calendar days commencing on the third working day of notification through confirmed fax <u>that the approved Purchase Order/Contract is already available for pick-up</u>. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.
- 3) Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4) Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
