- 1) The University of the Philippines-Manila, through *Fund 101* intends to apply the sum of **SIXTEEN MILLION SIX HUNDRED THOUSAND PESOS ONLY (PhP16,600,000.00)** being the **Approved Budget for the Contract (ABC) to payments under the contract for SUPPLY OF Two (2) units COLONOVideoscope (PEDIA), Two (2) units VIDEogASTROSCOPE (PEDIA) & One (1) unit BRONCHOVIDEOSCOPE (ADULT) – (SINGLE BID).** Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The University of the Philippines-Manila now invites bidders, for the **SUPPLY OF Two (2) units COLONOVideoscope (PEDIA), Two (2) units VIDEogASTROSCOPE (PEDIA) & One (1) unit BRONCHOVIDEOSCOPE (ADULT) – (SINGLE BID).** Delivery of the Goods is required **within sixty (60) calendar days commencing on the third working day of notification through confirmed fax that the approved Purchase Order/Contract is already available for pick-up.** Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.
- 3) Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4) Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
