SUPPLY OF VARIOUS EQUIPMENT FOR COMMUNICATION AND TRAINING PURPOSES AND OTHER EMERGENCY RELATED SITUATION OF UP-DDRM-H

- 1. The University of the Philippines-Manila, through its Bids and Awards Committee 3 with Fund PR-Reprog-21-04-12 (R19-1345) intends to apply the sum of One Million Three Hundred Eighty Three Pesos & 00/100 (Php 1,383,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply of Various Equipment for Communication and Training Purposes and other Emergency Related Situation of UP-DRRM-H (Rebid). Bids received in excess of the ABC shall be automatically rejected during bid opening.
- 2. The University of the Philippines-Manila now invites bids for the <u>Supply of Various</u> Equipment for Communication and <u>Training Purposes</u> and <u>other Emergency</u> Related Situation of <u>UP-DRRM-H</u> (Rebid). Delivery Period is Forty Five (45) Calendar days from the receipt of an approved Purchase Order and Notice to Proceed.
 - Bidders should have completed, within **two** (2) **years** from the date of submission and receipt of bids, a contract similar to the Project <u>amounting to at least 50% of the ABC of this contract to be bid</u>. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- 6. Pre-Bid Conference will be conducted on 05 July 2021, 01:30PM via zoom. Interested Bidder should send the BAC3 Secretariat the name and email address of authorized representative who should be given access to join.
- 7. Bids must be delivered to the address below on or before **19 July 2021, 11:30 a.m.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **ITB** Clause 18. Late bids will not be accepted/opened.
