TERMS AND CONDITIONS

- 1. Any delivery already accepted and paid for if found defective during utilization due to manufacturing defect, improper storage or mishandling shall be replaced by the supplier.
- Deliveries of reagents shall have at least six (6) months expiration date. For items which have a shorter expiry date or shelf life, the supplier should submit together with the delivery a certification letter that it will replace the unconsumed quantity three (3) months prior to expiration
- 3. Sufficient stocks for one (1) year
- 4. For non-delivery of the winning bidder of a particular item in prescribed period allowed, purchase order will be prepared in favor of the next lowest responsive bidder and charge the corresponding penalty to the defaulting supplier. This will in effect cancel the original purchase order of the undelivered item including the Notice of Award issued for the particular item.
- Complete labeling as per Food and Drug Administration requirements.
- The supplier guarantees that the contract price is the lowest in the market.
- In case the price in the open market is lower than the contract price, UP Manila PGH has the option to (a) ask the SUPPLIER to lower its price to the open market, or (b) terminate the contract.
- The quantities specified are the estimated requirements during the period and may be decreased depending upon the actual need of the hospital and availability of funds.
