Withdrawal of a bid, or refusal to accept an award, or enter into contract with the Government without justifiable cause, after the Bidder had been adjudged as having submitted the Lowest Calculated and Responsive Bid.</li><li>5. Refusal or failure to post the required performance security within the prescribed time.</li><li>6. Refusal to clarify or validate in writing its bid during post-qualification within a period of seven (7) calendar days from receipt of the request for clarification.</li><li>7. Any documented unsolicited attempt by a bidder to unduly influence the outcome of the bidding in his favor.</li><li>8. Failure of the potential joint venture partners to enter in to the joint venture after the bid is declared as successful.</li><li>9. 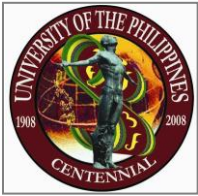
