INVITATION TO BID [RE-BID]

1. The University of the Philippines Manila (UPM) invites interested BIDDERS to submit proposals for the SPORTS AND WELLNESS CENTER PROJECT (PHASE 1).

The Approved Budget for the Contract (ABC) is **THIRTY ONE MILLION SEVEN HUNDRED EIGHTEEN THOUSAND NINE HUNDRED NINETY FOUR PESOS AND EIGHTY ONE CENTAVOS (Php 31,718,994.81)**; Source of Fund: Incremental Tuition Fund.

2. PROJECT DESCRIPTION:

The project shall cover the construction of the Sports and Wellness Center (Phase 1). The three-storey structure with mezzanine has total floor area of 3,500 sq.m.
