- 1) The University of the Philippines-Manila, through *Fund 101* intends to apply the sum of <u>ONE MILLION EIGHT HUNDRED THOUSAND PESOS ONLY (PhP1,800,000.00)</u> being the Approved Budget for the Contract (ABC) to payments under the contract for <u>SUPPLY OF One (1) unit DIAGNOSTIC AND THERAPEUTIC BRONCHOSCOPE with ACCESSORIES (SINGLE BID) REBID.</u> Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2) The University of the Philippines-Manila now invites bidders for the SUPPLY OF One (1) unit DIAGNOSTIC AND THERAPEUTIC BRONCHOSCOPE with ACCESSORIES (SINGLE BID) REBID. Delivery of the Goods is required within sixty (60) calendar days commencing on the third working day of notification through confirmed fax that the approved Purchase Order/Contract is already available for pick-up. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.
- 3) Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 4) Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
