- 3. Delivery should be done within sixty (60) calendar days commencing on the 3rd working day of notification through confirmed fax that the approved Purchase Order / Contract is already available for pick-up.
- 4. Certificate of authorized distributorship for the item being offered.
- 5. Notarized certificate accompanied by proof that the bidder must be in the business of supplying the above item / equipment for the last for the last three (3) years.
- 6. Notarized certificate that the bidder and its principal must have been in business relationship for at least three (3)
- 7. Notarized certificates of good track records within three (3) years from at least two (2) government and/or private hospitals within Metro Manila.
- 8. Three (3) years comprehensive warranty. This include at least four (4) preventive maintenance per year and unlimited corrective maintenance per year and unlimited corrective maintenance and parts.
