WHEREAS, on January 8, 2014, the scheduled pre-bid conference, no one participated;

WHEREAS, on January 22, 2014, the scheduled date for the submission and opening of bids, no one dropped bid; hence the committee scheduled the rebid on February 5, 2014;

WHEREAS, the Bids and Awards Committee III (BAC III) of the University of the Philippines Manila published the Invitation to bid - Rebid for the Supply of One (1) Lot Drug Analyzer (Drug of Abuse Testing Machine) for College of Medicine – Dept of Pharmacology in the Manila Standard and posted in the UP Manila website, the PhilG-EPS and in the BAC III Bulletin Board at the premises of the Joaquin Gonzales Hall, University of the Philippines Manila continuously for 13 days;

WHEREAS, On February 5, 2014, the scheduled date for the submission and opening of bids, since no one participated, the committee scheduled for negotiation on February 19, 2014;

WHEREAS, the Bids and Awards Committee III (BAC III) of the University of the Philippines Manila posted the Request for Quotation - Negotiation for the Supply of One (1) Lot Drug Analyzer (Drug of Abuse Testing Machine) for College of Medicine – Dept of Pharmacology in the UP Manila website, the PhilG-EPS and in the BAC III Bulletin Board at the premises of the Joaquin Gonzales Hall, University of the Philippines Manila continuously for 14 days;

WHEREAS, On February 19, 2014, the scheduled date for the submission and opening of price quotation, only Elite Scientific & Diagnostic Int'l Supplies, Inc. participated;

WHEREAS, on the same date, the price quotation of Elite Scientific & Diagnostic Int'l Supplies, Inc. is Php7,500,000.00;

WHEREAS, on March 26, 2014, the end user evaluated and recommended the award to Elite Scientific & Diagnostic Int'l Supplies, Inc. the complying bidder for having met their requirements;

WHEREAS, on the same date, after careful examination, validation and verification of all the eligibility, technical, financial and post-qualification requirements submitted by Elite Scientific & Diagnostic Int'l Supplies, Inc. and after a review of the post-qualification report, the committee resolved to recommend the award for the Supply of One (1) Lot Drug Analyzer (Drug of Abuse Testing Machine) for College of Medicine – Dept of Pharmacology to Elite Scientific & Diagnostic Int'l Supplies, Inc. its bid having been found to be responsive;
