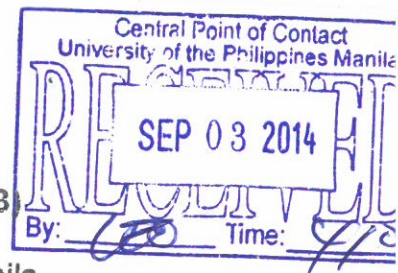

RESOLUTION NO. BAC-2014-43

RECOMMENDING AWARD OF THE CONTRACT FOR THE REBID OF SUPPLY OF VARIOUS LABORATORY EQUIPMENT (UV-VIS SPECTROPHOTOMETER) FOR NIH-IPS TO SIGMATECH INC. THROUGH PUBLIC BIDDING UNDER R.A. 9184

WHEREAS, the Bids and Awards Committee III (BAC III) of the University of the Philippines Manila posted the Invitation to bid for the Rebid of Supply of Various Laboratory Equipment (UV-VIS Spectrophotometer) in the UP Manila website, the PhilG-EPS and in the BAC III Bulletin Board at the premises of the Joaquin Gonzales Hall, University of the Philippines Manila continuously for 8 days;

WHEREAS, in response to the said postings, ITS Science Phils. Inc. and Sigmatech Inc. purchased the bid documents;

WHEREAS, on June 25, 2014, the scheduled date for the submission and opening of bids, two (2) suppliers namely: ITS Sciences Phils. Inc. and Sigmatech Inc. participated;

WHEREAS, on the same date, the envelope (Eligibility and Technical Proposal) of ITS Science Phils. Inc. and Sigmatech Inc. were opened and passed the eligibility and technical evaluation;


WHEREAS, on the same date, the second envelope (Financial Proposal) were opened by the BAC III and the bid prices were as follows: ITS Science Phils. Inc. Php588,000.00 and Sigmatech Inc. Php574,000.000;

WHEREAS, on April 30, 2014, the end-user evaluated and recommended the award to Sigmatech Inc. the complying bidder for having met their requirements;

WHEREAS, on the same date, after a careful examination, validation and verification of all the eligibility, technical, financial and post-qualification requirements submitted by Sigmatech Inc. and after a review of the post qualification report, the Committee resolved to recommend the award for the Supply of Various Laboratory Equipment (UV-VIS Spectrophotometer) for the NIH-IPS to Sigmatech Inc. its bid having found to be the lowest responsive bid;
