WHEREAS, the Bids and Awards Committee 3 of the University of Philippines Manila simultaneously posted the Invitation to Bid for the Installation of Security Gates and Book Tags for the College of Dentistry Library, with total approved budget of One Million Seven Hundred Nine Thousand Two Hundred Forty Three Pesos (Php1,709,243.00) with funding for the Modernization of the Laboratory, Research and Teaching Equipment under the GAA Funds 2015, posted at the UP Manila website, PhilG-EPS and in the BAC 3 Bulletin Board at the premises of the Joaquin Gonzales Hall, University of the Philippines Manila on 06 September 2016;

WHEREAS, in response to the said postings, two (2) suppliers namely American Technologies, Inc. and Cylics Technologies, Inc. purchased the bid documents;

WHEREAS, during the pre-bid conference held on 13 September 2016, it was only American Technologies, Inc. who attended the conference and submitted bid envelope on 27 September 2016;

WHEREAS, after the opening of the first envelope (Eligibility and Technical Proposals), the lone bidder was declared eligible and likewise "passed" the technical evaluation, hence the opening of the financial envelope;

WHEREAS, the total bid price submitted amounting to P1,699,643.00 is within the approved budget for the contract of P1,709,243.00;

WHEREAS, on 13 October 2016, the end-user evaluated and recommended the award for the Installation of Security Gates and Book Tags for the College of Dentistry Library, to American Technologies, Inc.;

WHEREAS, on 25 October 2016, after a careful examination, validation and verification of all the eligibility, technical, financial and post-qualification requirements submitted by American Technologies, Inc. and after a review of the post qualification report, the Committee resolved to recommend the award for the Installation of RFID Security Gates and Book Tags to American Technologies, Inc., its bid having been found to be the single responsive and complying bid;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED to recommend the award of the contract for the installation of RFID Security Gates and Book Tags to American Technologies, Inc. at the bid price of P1,699,643.00.
