WHEREAS, in response to the said advertisement/posting, three (3) prospective bidders, namely; ZUELLIG PHARMA CORPORATION, OXFORD DISTRIBUTORS, INC. and RBC-MDC CORPORATION acquired the necessary bid documents:

WHEREAS, a **Pre-Bid Conference** was conducted last 12 March 2021 thru video conferencing or webcasting via zoom and others face to face which was attended by five (5) prospective bidders, namely; ZUELLIG PHARMA CORPORATION, OXFORD DISTRIBUTORS, INC., RBC-MDC CORPORATION, FIRST DAY PHARMA and SANKEN HEALTHCARE who made inquiries and clarifications on the technical specifications as well as the appropriate documents to be submitted;

WHEREAS, three (3) prospective bidders namely, **ZUELLIG PHARMA CORP., OXFORD DISTRIBUTORS, INC. and RBC-MDC CORPORATION** submitted their bid documents in time for the opening of bids on 26 March 2021 for the Supply and Delivery of Various Contrast Media and were rated as **“PASSED”** in re: the Eligibility requirements with the following bids;
