**RECOMMENDING AWARD FOR THE SUPPLY OF WRIST WORN ACTIVITY MONITOR  
SYSTEM FOR THE COLLEGE OF ALLIED MEDICAL PROFESSIONS, UP MANILA  
TO K.O.B.S CUSTOMERS FIRST TRADING, INC. THRU PUBLIC BIDDING UNDER RA 9184**

**WHEREAS**, the Bids and Awards Committee (BAC) 3 of the University of Philippines Manila posted the Invitation to Bid for the Supply of Wrist Worn Activity Monitor System for the College of Allied Medical Professions, with total approved budget of Two Million Pesos (Php2,000,000.00) with funding for Modernization of Laboratory, Research and Teaching Equipment from GAA 2015, in a newspaper of nationwide circulation and simultaneously posted at the UP Manila website, PhilG-EPS and in the BAC 3 Bulletin Board at the premises of the Joaquin Gonzales Hall, University of the Philippines Manila on 15 September 2016;

**WHEREAS**, in response to the said postings, two (2) suppliers, K.O.B.S. Customers First Trading Inc. and Quality Medical Trading purchased bid documents;

**WHEREAS**, during the pre-bid conference conducted on 20 September 2016 and attended by the authorized representatives from Quality Medical Trading, the specifications, terms of procurement and other details of the project were presented and clarified;

**WHEREAS**, bid envelope from only one (1) supplier, K.O.B.S. Customers First Trading Inc. was received within the deadline or before the 12:00 noon of 04 October 2016;

**WHEREAS**, after the opening of the first envelope (Eligibility and Technical Proposal), the lone bidder was declared eligible and likewise "passed" the technical evaluation, hence the opening of financial envelope;

**WHEREAS**, the bid price submitted is Php1,871,666.40 as against the approved budget for the contract of Php2,000,000.00;

**WHEREAS**, on 14 October 2016, the end user evaluated and recommended the award for the Supply of Wrist Worn Activity Monitor System to K.O.B.S. Customers First Trading Inc.;

Customers First Trading Inc., its bid having been found to be the single responsive and complying bid;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby RESOLVED to recommend the award of the contract for the Supply of Wrist Worn Activity Monitor System to K.O.B.S. Customers First Trading Inc. at the bid price of Php1,871,666.40.




