During the pre-bidding conference held on May 27,2022, the end users requested the bidder to provide brochures and allow them to visit an installation site for them to evaluate the readability of information on a 5.7-inch user interface. The bidder, however, did not provide any information in order for the end users to properly evaluate their offered product.
7	Rotary Sealer At least 10 m/min sealing speed <i>The bidder is requesting to consider to delete the sealing speed of the rotary sealer or manufacturer standard.</i>	Request denied. In as much as we would like to accommodate the request of the supplier, it would have been prudent for them to have written down what is their “manufacturer’s standard speed of sealing”. Since a Rotary Sealer is a third-party item and can be procured with third party suppliers, we will keep this requirement.
