SUPPLY OF -80C ULTRALOW FREEZER WITH ACCESSORIES

1. The **University of the Philippines-Manila**, through **F184-2020105000** intends to apply the sum of **One Million Pesos & 0/100 (Php 1,000,000.00)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **Supply of -80C Ultralow Freezer with Accessories.** **Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. The University of the Philippines-Manila now invites bids for **Supply of -80C Ultralow Freezer with Accessories.** Delivery of the Goods is required **Thirty (30) Calendar Days from receipt of Contract/Purchase Order.** Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) or Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulation of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from University of the Philippines-Manila and inspect the Bidding Documents at the address given below during office hours from 8:00 a.m. to 5:00 p.m.
5.
