Invitation to Bid

 The University of the Philippines Manila (UPM) hereby invites UPM-PGH registered contractors and interested parties to participate in the bidding for the procurement of the following infrastructure projects as funded by 2018 General Appropriations Act/Programmed and Realigned Fund/Donation.

Bids received in excess of the ABC (based on the allocated fund source) and the total amount of the project shall be automatically rejected at bid opening.

- 2. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
 - Bidding is restricted to Filipino citizens/sole proprietorships, corporations, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 3. Interested bidders may obtain further information from Special Bids and Awards Committee (SBAC) Secretariat and inspect the Bidding Documents at the address given below from Monday to Friday, except Weekend, Holidays, or suspension of work, 8:00AM to 5:00PM.
- 4. A complete set of Bidding Documents may be acquired by interested bidders on **15 October 2018**, **Monday to Friday**, *except Weekend*, *Holidays*, *or suspension of work*, **8:00AM to 5:00PM** from the address below, and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Seventy-Five Thousand Pesos (PhP75,000.00).**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 5. The BAC will hold a Pre-Bid Conference on **23 October 2018**, **9:00AM** at **EHRO Conference Room**, **2**nd **floor**, **Administration Building**, **Philippine General Hospital**, **Taft Avenue**, **Ermita**, **Manila**, which shall be open to prospective bidders.
- 6. Bids must be dropped and duly received at the BAC I Office, PGH Compound, Philippine General Hospital, Taft Avenue, Ermita, Manila on or before 8 November 2018, at 9:00AM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- 7. Bid opening shall be on 8 November 2018, at 9:30AM at the BAC I Office, PGH Compound, Philippine General Hospital, Ermita, Manila. Bids will be opened in the presence of the bidders' representatives who choose to attend at the aforementioned address. Late bids shall not be accepted.
- 8. Interested bidders shall be required to submit PCAB License applicable to the type and cost of this project and classification of contractors as Large "B" for Buildings, ISO 9001 Certification, Quadruple A PCAB License and a completed single contract that is similar to the project equivalent to at least 50% of the ABC. Also, a similar contract for a hospital or medical facility with a floor area of at least 20,000 square meters, as part of the technical documents shall be required.
- 9. The PGH reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
