



TERMS AND CONDITIONS:

- Delivery of the winning bidder amounting to P20,000.00 and above will still be subjected to the PHILIPPINE TEXTILE RESEARCH INSTITUTE (PTRI) test for the other criteria like cotton count, composition and shrinkage. If the result from the PTRI does not conform with the required specifications indicated in the bid forms, deliveries will be rejected and replacement shall be required thereof. For non-replacement, the corresponding penalty for non-delivery shall be imposed. Payment for the PTRI testing is at the expense of the supplier.
- Delivery schedule: Sixty (60) working days (for cloth oxford blue) & muslin unbleached upon receipt of Purchase Order
- All price quotations must include all taxes and duties imposed by the Government on the supplies offered and any additional impositions which may be made by the Government during the effectivity of the contract shall be the sole responsibility of the supplier/s concerned.
- The quantities specified are the estimated requirements during the period and may be increased or decreased depending upon the actual need of the hospital and availability of funds. It is understood therefore that the hospital is not bound to order/purchase all the quantities/items called for in the invitation to bid (ITAEB)
