## TERMS AND CONDITIONS

- 1. The supplier should have the chemicals and reagents available at all times in their warehouses.
- 2. Any delivery accepted and paid for if found defective during utilization due to manufacturing defect, improper storage or mishandling shall be replaced by the supplier.
- 3. Delivery of reagents shall have at least six (6) months expiration date. Submit together with the delivery an assurance letter that it will replace unconsumed delivered items expiring within three (3) months.
- Sufficient stocks for one year.
- 5. For non-delivery of the winning bidder of a particular item in prescribed period allowed, purchase order will be prepared in favor of the next lowest bidder and charge the corresponding penalty to the defaulting supplier. This will in effect cancel the original purchase order of the undelivered item including the Notice of Award issued for the particular item.
- 6. The supplier guarantees that the contract price is lowest in the market.
- 7. In case the price in the open market is lower than the contract price, UP Manila-PGH has the option to (a) ask the SUPPLIER to lower its price to the open market, or (b) terminate the contract.
- 8. Compliance with the provisions of Republic Act No. 9184 and other applicable laws.
