

TERMS AND CONDITIONS

- Winning bidders for cytotoxic injectible are required to submit the following to Pharmacy 1. Department under the first Purchase Order:
 - a. Material Safety Data Sheets
 - b. Spill Kits (2pcs)
 - c. Drug Profile
- Deliveries shall have at least one (1) year expiration date. The supplier should submit together 2. with the delivery an assurance letter that it will replace unconsumed delivered items expiring within two (2) months.
- Stocks delivered are subjected to random sampling for testing as to quality and conformity 3. label. Expenses for random sampling will be charged to the winning bidder.
- Payment is upon completion of units in PO. 4.
- For non-delivery of the winning bidder of a particular item in prescribed period allowed, 5. purchase order will be prepared in favor of the next lowest responsive bidder and charge the corresponding penalty to the defaulting supplier. This will in effect cancel the original purchase order of the undelivered item including the Notice of Award issued for the particular item.
