

TERMS AND CONDITIONS


- 1 Stocks delivered are subjected to random sampling for testing as to quality and conformity to label. Expenses for random sampling will be charged to the winning bidder.
- 2 Sufficient stocks for one (1) year.
- 3 Payment is upon completion of units in the PO.
- 4 For non-delivery of the winning bidder of a particular item in prescribe period allowed, purchase order will be prepared in favor of the next lowest responsive bidder and charge the corresponding penalty to the defaulting supplier. This will in effect cancel the original purchase order of the undelivered item including the Notice of Award issued for the particular item.
- 5 The supplier guarantees that the contract price is the lowest in the market.
- 6 The quantities specified are the estimated requirements during the period and may be decreased depending upon the actual need of the hospital and availability of funds. 
