Description

1. The University of the Philippines Manila – Philippine General Hospital (UPM-PGH), using a single-year Framework Agreement, through the General Appropriations Act CY 2021 intends to apply the sum of Ninety Million Thirty Six Thousand Three Hundred Fifty Pesos & 00/100 (PhP90,863,050.00), inclusive of all taxes, such as, but not limited to, value added tax (VAT), income tax, local taxes, and other fiscal levies, being the ABC to payments under the contract for each item. Bids received in excess of the total cost per item shall be automatically rejected.
2. The University of the Philippines Manila – Philippine General Hospital (UPM-PGH) now invites bids for Supply and Delivery of Medical Supplies for Cardiac Cathlab (Framework Agreement). Delivery of the Goods is required within seven (7) calendar days after issuance of Call-Off. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
