## **Description**

INVITATION TO BID FOR Supply and Delivery of Radiopharmaceuticals -Framework Agreement

- 2. The University of the Philippines Manila Philippine General Hospital (UPM-PGH) now invites bids for Supply and Delivery of Radiopharmaceuticals Framework Agreement. Delivery of the Goods will be on staggered basis. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project.
