4. Warranty period of 2 years parts and 2 years services.

5. Warranty period shall commence from the date of acceptance by the end-use after testing and commissioning.

6. Provide regular quarterly preventive maintenance during the warranty service.

- 7. Provide a certification issued by the Pediatric Chairman after the item/unit has been demonstrated and/or site visited/inspected and evaluated by the Task force Head
- 8. A notarized certification of authorized distributorship from the principal manufacturer mentioning the name of the Philippine representative.
